VI. Discipline Policy

When problems arise, the following procedures will be followed:

- The teacher will remind the student of what is acceptable behavior within the classroom.
- If a student continues to behave inappropriately, s/he will be separated from the group.
- If the disruptive behavior continues, the student will be sent to the Director of Youth Education and parents will be contacted.
- The second time a student is sent to see the Director of Youth Education, his/her parents will be called and the child will be admitted to class only following a meeting between student, parents, teacher, Director of Youth Education, Director of Formal and Informal Education and the Rabbi.
- If inappropriate behavior continues, the parents will be required to sit in the class with their child to help him/her maintain self-control.

Gum chewing in the sanctuary and the classroom is forbidden. Students are prohibited from bringing radios, cell phones, toys, games and sports equipment to class. Not only do they detract from the learning process, but they will be confiscated by the teacher and returned at the Director of Youth Education's discretion.

VII. Tuition Policies for NON-MEMBERS

- All Religious School fees are DUE IN FULL by August 1, 2011.
- If Religious School tuition obligations are not met by August 1, 2011 Har Sinai Congregation Religious School will delay or refuse admission to your child(ren).
- If the child(ren) are withdrawn after August 31, 2011, a minimum of 25 percent of the annual school fees will not be refunded. The remainder of the Religious School fees will be prorated based on the number of weeks school has been in session prior to parental notification of withdrawal.
